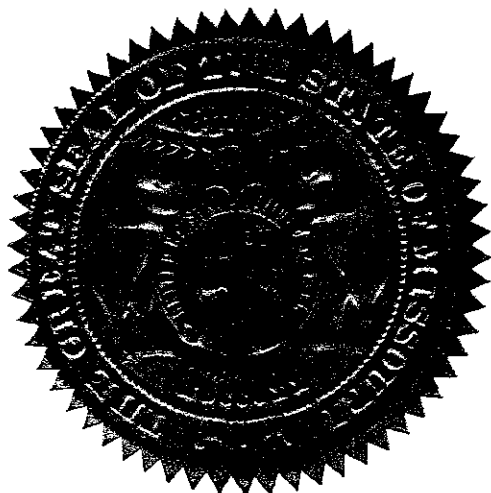

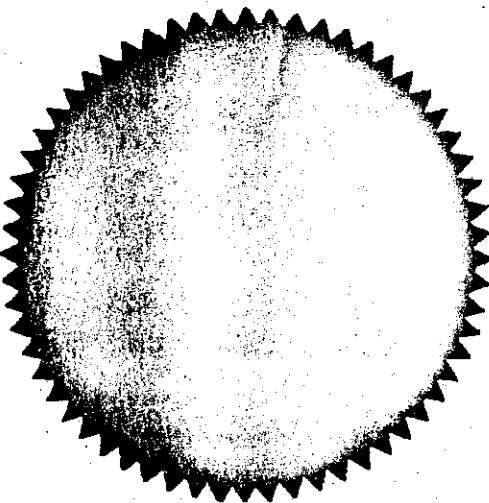

CERTIFICATE OF AMENDMENT OF ARTICLES OF INCORPORATION  
OF  
RUSSELL STOVER CANDIES, INC.

The undersigned, Russell Stover Candies, Inc., a Missouri corporation (hereinafter called the "Corporation"), for the purpose of amending the Articles of Incorporation of the Corporation, in accordance with the provisions of The General and Business Corporation Law of Missouri, does hereby make and execute this Certificate of Amendment and does hereby certify as follows:

I. The name of the Corporation is:

RUSSELL STOVER CANDIES, INC.

The Corporation was originally organized under the name of Business Ventures, Inc.

II. The amendment set forth below was adopted by the shareholders of the Corporation at the Annual Meeting of the Shareholders of the Corporation held on December 16, 1974.

III. The following resolution sets forth the amendment to be adopted:

RESOLVED, that the Articles of Incorporation of this Corporation, as heretofore amended, be and they hereby are, further amended by deleting the present Article SIXTH thereof and by inserting in lieu thereof the following new Article SIXTH:

ARTICLE SIXTH

The number of directors to comprise the board of directors shall be ten (10). Directors need not be shareholders of the corporation.

IV. The number of shares of stock outstanding and the number of shares entitled to vote on the foregoing amendment was 6,609,500 shares of Common Stock, with par value of \$1 per share.

V. The number of shares of Common Stock of the Corporation voted at said meeting for the said amendment was 4,975,000 shares and the number of shares of Common Stock of the Corporation voted at said meeting against said amendment was 54,651 shares.

VI. The foregoing amendment was, in accordance with the provisions of The General and Business Corporation Law of Missouri, adopted by the affirmative vote, at said meeting, of a majority of the outstanding shares of stock of the Corporation.
