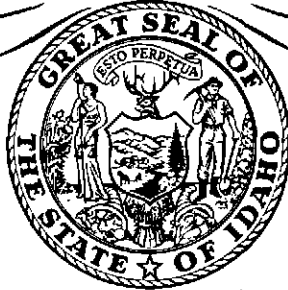


We, BOB W. KNUDSEN, President, and BOB J. KNUDSEN, Secretary

of the following resolution:


RESOLVED, that the name of said corporation be changed




