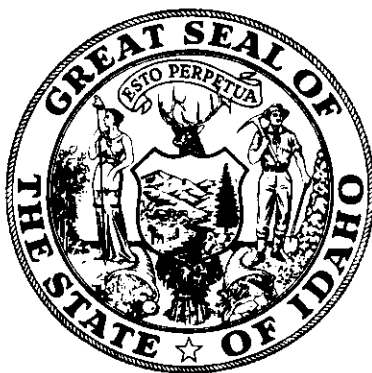

ARTICLES OF INCORPORATION OF

Ida-Mex

Corporation

KNOW ALL MEN BY THESE PRESENTS:

That we, the undersigned, for the purpose of forming a corporation under the laws of the State of Idaho, relating to ~~entertainment~~ and business corporations, have entered into the following agreement:

FIRST: That the name of the corporation shall be Ida-Mex Corp.

SECOND: That the corporation shall be located in the city of Wilder

THIRD: That the amount of the capital stock is fifteen thousand (\$15,000.00), divided into 150 shares of the par value of one hundred dollars (\$100.00) each; that the same has been bona fide subscribed and all thereof actually paid up in lawful money of the United States, and is in the custody of the persons hereinafter named as the first board of directors.
