ARTICLES OF INCORPORATION OF THE

ATHAMBRA MINING COMPANY, LIMITED

KNOW ALL MEN BY THESE PRESENTS: That we, the undersigned, have this day voluntarily associated ourselves together for the purpose of forming a corporation under the laws of the State of Washington, and we haveby certify in triplicate as follows, to-wit:-

Article 1.

That the name of this corporation shall be the ALHAMERA MINING.

Article 11.

That the term for which this corporation shall exist is fifty years from and after the date of its incorporation.

Article 111.

That the amount of the capital stock of this corporation shall be One Million (\$1.000.000.000) Dollars, divided into One Million (1.000.000) shares of the par value of One (\$1.00) Dollar each.

Article 1V.

That the purposes for which this corporation is formed are to locate, buy, sell, lease, bond, develop, work, operate and deal in minerals, mineral claims, and mining properties of every kind and description in the States of Idaho and Washington and other States of the United States of America.

And also to carry on the business of purchasing, selling, milling, smelting, matting, stamping and reducing ores and minerals of every kind and description in the States of Idaho and Washington and other States of the United States of America.

And also to buy, sell, erect and operate electric lights and power plats for the purpose of mining and treating ores, in the States of Idaho and Washington, and other States of the United States of America.

And also to locate, buy, sell, lease, bond and deal in water rights, and to build, buy, sell, lease, operate and deal in ditches, flumes, dama, reservoirs and other works of similar character, in the States of Idaho and Washington, and other States of the United States of America.

And also to locate, buy, sell, lease and deal in mill sites, and to buy, sell, lease, construct, bond, work, operate and deal in mills, concentrators, smelters, reduction works, saw mills, warehouses, and mining machinery, materials and buildings, in the States of Idaho and Washington, and other States of the United States of America.
