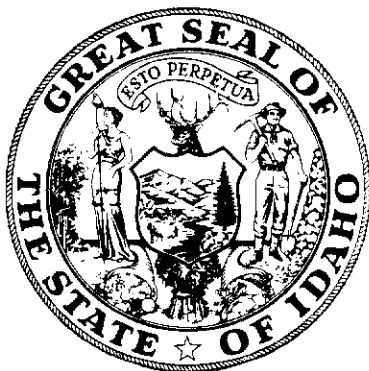

The undersigned, Kermit D. Zahm, President of said corporation, and Robert T. Adams, Secretary of said corporation, do hereby respectively certify as follows:

I.

That a meeting of all of the stockholders of Les Bois Cabinet, Inc. an Idaho corporation, was held on October 7, 1986, at 4376 Apple, Boise, Idaho, pursuant to Call and Waiver of Notice signed by all of the stockholders and filed in the Minute Book of the corporation.

That at such meeting the following resolution was presented, and upon motion duly made, seconded and unanimously carried, the same was adopted:

BE IT RESOLVED, That the Articles of Incorporation of Les Bois Cabinet, Inc. be amended by changing the title thereof to read as follows:


