ARTICLES OF INCORPORATION

OF THE

COMMUNITY BAPTIST CHURCH, INCORPORATED OF A HOVALLA, IDAHO KNOW ALL MEN BY THESE PRESENTS:

That we, the undersigned members of the Baptist Church, do hereby, in accordance with the rules of such society and under and by virtue of the laws of the state of Idaho, incorporate ourselves and form a corporation, as follows, to-wit:

FIRST The name of this Corporation shall be the "Midvale Community Baptist Church Incorporated."

SECOND This corporation is formed for the following purposes, to wit:

- (a) To conduct church services and other allied activities under the direction of the general authority of the Baptist Church.
- (b) For the purposes above specified, to own and hold title to real estate and personal property, and to acquire real estate and personal property by gift, grant, devise, or bequest, as may be necessary for the purposes of this organization.
- (c) To receive donations, borrow money, give security therefore, and to execute notes and mortgages for the benefit of all church activities.
- (d) To employee ministers and other necessary help and to do any and all things necessary to carry into effect the provisions herein set out.

Pecuniary profit is not the object of this organization.

THIRD That the value of the property presently held by this organization is estimated to be the sum of \$30,000.00.

FOURTH That the place where its principal place of business shall be transacted shall be in the Village of Midvale, Washington County, State of Idaho.

FIFTH That the names and residences of the present trustees and incorporators of this organization are:

Clifford Hopper--Midvale, Idaho Roy Curts--Midvale, Idaho Clarence Bluemer--Midvale, Idaho SIXTH The number of directors or trustees shall be three (3). The names and residences of those who are selected for the first year and until the election of their successors, are:

Clarence Bluemer Midvale; Idaho Clifford Hopper Midvale; Idaho Roy Curts Midvale, Idaho

SEVENTH That there is no capital stock and there are no shares of stock, and the term of existance of this cooperation shall be fifty (50) years.
