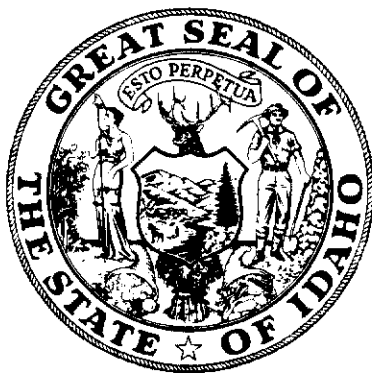

ARTICLES OF FIRST AMENDMENT TO ARTICLES OF INCORPORATION
OF

TWIN FALLS COUNTY 4H - FFA FAT STOCK SALE COMMITTEE, INC.

3 1. Pursuant to the provisions of Idaho Code §30-326, Twin
4 Falls County 4H - FFA Fat Stock Sale Committee, Inc., has amended
5 its Articles of Incorporation as follows:

6 Article IV of the Articles of Incorporation of said Corpora-
7 tion has been amended by adding the following subparagraphs:

8 (d) This Corporation is organized exclusively for
9 educational purposes within the meaning of Section
501(c)(3) of the Internal Revenue Code.

10 (e) Notwithstanding any other provision of these
11 Articles, the Corporation shall not carry on any other
12 activities not permitted to be carried on by an
organization exempt from Federal income tax under
Section 501(c)(3) of the Internal Revenue Code.

13 (f) Upon the winding up and dissolution of this
14 Corporation, after paying or adequately providing for
15 the debts and obligations of the Corporation, the re-
16 maining assets shall be distributed to a non-profit
fund, foundation or corporation which has established
its tax exempt status under Section 501(c)(3) of the
Internal Revenue Code.

17 2. Said Amendment was adopted by and with the consent of
18 the membership of the Corporation at a meeting held on April
19 13, 1989, at which meeting a quorum was present and said
20 Amendment received a majority of the votes which members present
21 at the meeting were entitled to cast.
