## AS AMENDED TO FEBRUARY 27, 2007

On May 2, 1908 the Children's Home Finding and Aid Society of Idaho (the "Corporation") was incorporated as an Idaho not-for-profit corporation;

On October 27, 1971 the Corporation's Articles were amended to, among other things, change the name of the Corporation to the Children's Home Society of Idaho;

On October 15, 1996, the Corporation's Articles were amended and restated, in their entirety, to among other things, eliminate members from the Corporation. A total of fourteen (14) Members of the Board of Directors and Members of the Corporation, representing a quorum as required by these Articles of Incorporation, and duly authorized to vote upon matters of the Corporation, were present at the annual meeting on October 15, 1996, and unanimously approved the following amended and restated Articles of Incorporation of the Corporation, in their entirety, in accordance with and under and pursuant to the Idaho Nonprofit Corporation Act, and therefore, do hereby amend and restate all of the Articles within these Articles of Incorporation of Children's Home Society of Idaho, an Idaho nonprofit corporation;

On February 27, 2007, the Bylaws of the Corporation were amended by a unanimous vote of the Board of Directors to expand the number of Directors from twenty five (25) to thirty (30).

## ARTICLE L NAME.

The name of the Corporation is "Children's Home Society of Idaho"

## ARTICLE IL NONPROFIT STATUS.

The Corporation is a nonprofit corporation.

## ARTICLE III. PERIOD OF DURATION.

The period of duration of the Corporation is perpetual.

## ARTICLE IV. INITIAL REGISTERED OFFICE AND AGENT.

The address of the initial registered office of the corporation is 740 Warm Springs Avenue, Boise, Idaho 83712. The name of the initial registered agent at this address is Kara Craig.

#### ARTICLE V. PURPOSES.

The purposes for which the Corporation is exclusively organized and will be operated are as follows:

- A. To promote the well-being of all children and their families through quality mental health services, education and training.
- B. Charitable, religious, educational, and scientific within the meaning of Section 501(c)(3) of the Internal Revenue Code of 1986, as amended from time to time, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under such Section 501(c)(3).
- C. To exercise all powers granted by law necessary and proper to carry out the above-stated purposes, including but not limited to the power to accept donations of money, property, whether real or personal, or any other thing of value. Nothing herein contained shall be deemed to authorize or permit the Corporation to carry on any business for profit, to exercise any power, or to do any act that a corporation formed under Act, or any amendment thereto or substitute therefor, may not at that time lawfully carry on or do.

#### ARTICLE VI. LIMITATIONS.

No part of the net earnings or the assets of the Corporation shall insure to the benefit of, or be distributable to, its directors, officers, or other private persons except that the Corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article V hereof. No substantial part of the attempting to influence legislation, and the Corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of any candidate for public office. Notwithstanding any other provision of these articles, the Corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under time, or the corresponding section of any future federal tax code, or (b) by a corporation, contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code of 1986, as amended from time to time, or the corresponding section of any future federal tax code.

#### ARTICLE VII. MEMBERS.

The Corporation shall have no members.

#### ARTICLE VIII. BOARD OF DIRECTORS.

The affairs of the Corporation shall be managed by its Board of Directors. The Board of Directors shall consist of not less than eleven (11) nor more than thirty (30) individuals. The actual number of Directors shall be fixed by the Bylaws of the Corporation. Other than the Directors constituting the initial Board of Directors, who are designated in these Articles, the Directors shall be elected or appointed by the existing Directors in the manner and for the term provided in the Bylaws of the Corporation.

## ARTICLE IX. DISTRIBUTION ON DISSOLUTION.

Upon dissolution of the Corporation, the Board of Directors shall, after paying or making provision for the payment of all liabilities of the Corporation, distribute all the assets of the Corporation consistent with the purposes of the Corporation to such organization or organizations as shall at the time qualify as exempt organizations under Section 501(c)(3) of the Internal Revenue Code of 1986, as amended from time to time, or the corresponding section of any future federal tax code, in such manner as the Board of

Directors shall determine, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so distributed by the district court of the county in which the principal office of the Corporation is then located, exclusively for such purposes or to such organizations, as such court shall determine to be consistent with the purposes of the Corporation.

## ARTICLE X. BYLAWS

Provisions for the regulation of the internal affairs of the Corporation shall be set forth in the Bylaws.
