ARTICLES OF INCORPORATION

I, the undersigned, being a natural person of full age, and a citizen of the United States or of its territories or possessions, have this day voluntarily adopted the following articles of incorporation for the purpose of forming a pirvate corporation under the laws of the State of Idaho:

ARTICLE I

Name

The name of this corporation shall be MONETA INC.

ARTICLE II

Duration

This corporation shall have a perpetual existence.

ARTICLE III

Purposes

The objects and purposes for which said corporation is formed are as follows:

The transaction of any and all lawful business for which
corporations may be incorporated under the General Business
Corporation Act, Title 30, Chapter I, Idaho Code.

ARTICLE IV

Capital Stock

The amount of capital stock of this corporation shall be Fifty Thousand Dollars (\$50,000.00) divided into five hundred shares of common stock, each being of a par value of one hundred (\$100.00) per share. The aggregate par value of the total amount of authorized shares shall be Fifty Thousand Dollars (\$50,000.00), and each share shall be entitled to one vote in the organization and conduct of the proposed corporation business. The shares of this corporation shall be nonassessable. The private property of the members shall not be subject to the payment of any corporate debts of whatever kind, nature, or extent.

ARTICLE V
