The undersigned natural persons of the age of eighteen years or older, acting as incorporators of The Rivers Cafe, Inc., under the Idaho Business Corporation Act, adopt the following articles of incorporation:

# ARTICLE I

NAME

The name of this Corporation is "The Rivers Cafe, Inc."

**ARTICLE II** 

**DURATION** 

This Corporation shall have perpetual existence.

**ARTICLE III** 

**PURPOSE** 

The purpose of the Corporation is to engage in any lawful act or activity for which corporations may be organized under the Idaho Business Corporation Act.

This Corporation shall be authorized to acquire, own, operate and dispose of restaurants and other food establishments.

#### ARTICLE IV

#### CAPITALIZATION

This Corporation shall have authority to issue an aggregate of ten thousand (10,000) shares of stock. This Corporation shall have one (1) class of stock. The class, aggregate number and par value per share of the shares which the Corporation is authorized to issue are as follows:
