ARTICLES OF INCORPORATION

OF

FIRST AMERICAN TITLE COMPANY OF BONNERS FERRY, INC.

The undersigned, acting as incorporators of a corporation under the Idaho Business Corporation Act, hereby adopts the following Articles of Incorporation for such corporation.

ARTICLE I.

The name of the corporation shall be FIRST AMERICAN TITLE COMPANY OF BONNERS FERRY, INC.

ARTICLE II.

The period of existence and duration of the life of this corporation shall be perpetual.

ARTICLE III.

This corporation is organized for the purpose of the transaction of any or all lawful business for which corporations may be incorporated under the Idaho Business Corporation Act.

ARTICLE IV.

The total authorized number of shares of the corporation shall consist of One Hundred (100) shares of Common Stock having a par value of Two Hundred Fifty (\$250.00) Dollars per share for a total value in stock of Twenty Five Thousand (\$25,000.00) Dollars, all of one (1) class denoted Common Stock, each share being entitled to one (1) vote.
