

ARTICLES OF INCORPORATION

OF

THE FIRST MISSIONARY BAPTIST CHURCH OF SANDPOINT, INC.

The undersigned natural person, being of the age of eighteen years or more, and acting as the incorporator under the Idaho non-profit corporation law, adopts the following articles of incorporation:

ARTICLE I

The name of the corporation is the First Missionary Baptist Church of Sandpoint, **Inc.**

ARTICLE II

This corporation is being organized as a non-profit corporation.

ARTICLE III

The duration of the First Missionary Baptist Church of Sandpoint, **Inc.** shall be perpetual, subject to dissolution as provided by the law, its constitution and by-laws.

ARTICLE IV

The purpose for which this corporation is organized is to preach the gospel, to promote righteous living through worship, study, service and fellowship, founded on devotion and individual freedom of belief; and any lawful activity, reasonably related to said purpose which is not for profit and for which corporations may be organized under Idaho Non-profit Corporation Act; Title 30, Chap.3, Idaho Code.

ARTICLE V

The management of the affairs of this corporation shall be vested in members of said corporation pursuant to section 30-314(c), Idaho Code.

ARTICLE VI

The address of the original registered office of the corporation is 2530 W. Ontario, Sandpoint, Id. 83864, and the name of its registered initial agent is Kenneth D. Johnson.

ARTICLE VII
