ARTICLES OF AMENDMENT TO THE ARTICLES OF INCORPORATION OF CLEARWATER SKI CLUB, INCORPORATED

We, the undersigned, R. W. TONDEVOLD and W. R. WALKER, the President and Secretary of Clearwater Ski Club, Incorporated, do hereby certify that at the annual meeting of the members of said Corporation duly called and held on the 9th day of May, 1970, at seven o'clock P.M., at which meeting a quorum of members of the Corporation were represented in person, resolutions as hereinafter set forth were adopted by two-thirds majority vote by these members of the Corporation.

RESOLVED, That Article V of the Articles of Incorporation of Clearwater Ski Club, Incorporated, be, and the same hereby is, amended to read as follows:

ARTICLE V.

Section 1. This association shall not have capital stock, but its capital shall be represented by membership certificates.

Section 2. Under the terms and conditions prescribed in its By-Laws, the number of memberships in this association shall be limited to a maximum number of persons, groups of persons, organizations, or corporations which will be determined and set from time to time by the members of the Corporation.

RESOLVED, That Article VI of the Articles of Incorporation of Clear-water Ski Club, Incorporated, be, and the same hereby is, amended to read as follows:

ARTICLE VI.

The membership fee in this association shall be determined and set from time to time by the members of the Corporation. The voting power and property rights and interest of each member whose fees are fully paid and who is in good standing shall be equal, and each member shall be entitled to one vote only. New members upon their admission in this association shall be entitled to one vote and to share in the property of the association equally with the old members. When a member has paid his membership fee in full he shall receive a certificate of membership. Assessments against members and a determination of their liability shall be fixed by the By-Laws of the association.
