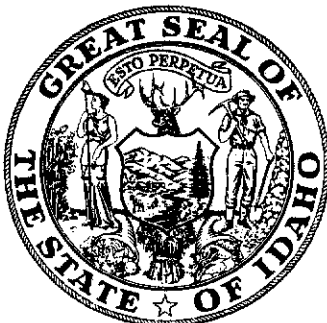

## Articles of Incorporation

We, the undersigned, as proper persons acting as incorporators of a corporation under the laws of the state of Idaho, adopt the following articles of incorporation:

**FIRST** The name of the corporation is: Savant Information Brokerage, Inc.

**SECOND** The period of its duration is: Until shareholders vote to dissolve the corporation

**THIRD** The purpose of the corporation is: This corporation may engage in or transact any and all lawful activities or business permitted under the laws of the United States, the State of Idaho, or any other state, county, territory, or nation.

**FOURTH** The aggregate number of authorized shares is: 100,000 at \$ 1.00

**FIFTH** The corporation will not commence business until at least \$25000.00 dollars have been received by it as consideration for the issuance of shares.

**SIXTH** Cumulative voting of shares of stock is authorized.

**SEVENTH** Provisions limiting or denying to shareholders the pre-emptive right to acquire additional or treasury shares of the corporation are: The stock of this corporation is intended to qualify under the requirements of Section 1244 of the IRS Code and the regulations issued thereunder.

**EIGHTH** Provisions for regulating the internal affairs of the corporation are: Such actions as may be necessary shall be deemed to have been taken by the appropriate officers to accomplish this compliance.
