ARTICLE OF INCORPORATION:-

Known all men by these presents, that we, the undersigned residents of the State of Idaho, have this day voluntarily associated ourselves together for the purpose of forming a corporation under the laws of the State of Idaho.

Article 1.

The name of the corporation shall be: The West Caldwell Ditch Association.

Article 2.

The purposes for which this corporation is formed are to own, and operate a lateral ditch, to supply water for the purpose of irrigation to lands in Sections, 28,(twenty eight,) & 33,(thirty three,) Town 4 North, Range 3 West B M, in Canyon County, Idaho, Beginning at the terminus of the Caldwell High line ditch, on the east line of the said Section 33; 1650 feet south of the N E corner of the Section; then running in a westerly course to a point 85 feet north of the N W corner, of the said Section 33.

Article 3.

The place where the principal business of the corporation is to be transacted is at the Office of this Company in West Caldwell, County of Canyon, State of Idaho: At the dwelling of *Frank Parker*.

Article 4.

The term for which this corporation is to exist is fifty years from the First day of May, 1904.

Article 5.

The numbers of directors of this corporation shall be five, and the names and addresses of those who are to act for the first year are:

J. P. Johnson, Edgar Meek, Thomas Waite, W. H. Schenck, *W. J. Livingstone McIntosh*, all of Caldwell Idaho.

Article 6.

The amount of the capital stock of this corporation shall be One Thousand Dollars, (\$1,000.00) divided into 1000 shares or the par value of One Dollar each.

Article 7.

The manner and time of holding the general annual meetings, and special meetings of stockholders for the election of officers and transaction of other business, shall be as provided in the by-laws to be hereafter adopted by this Company.
