



CHILDREN'S LEGAL FOUNDATION

BY - LAWS

ARTICLE I

NAME AND PURPOSE

The name of the corporation shall be "Children's Legal Foundation", but may also be referred to as "CLF".

The primary purpose of CLF is and shall be to provide expertise, advice, research, and assistance to educate and assist the public, governmental, educational, and law enforcement communities, on federal, state, and local levels, concerning the enactment and enforcement of constitutionally valid and effective statutes, ordinances, and regulations related to the public and commercial dissemination of obscenity and pornography and related activities.

The main programs to carry out these educational functions shall be through Public Education and Legal Assistance. Through Public Education, CLF shall work to bring to the attention of, and provide a forum for, the public, governmental, educational, and law enforcement communities the various legal, political, social, moral, philosophical, and economic issues and problems associated with the dissemination of pornography and obscenity in particular and sexual exploitation and abuses in public morality in general. To assist in this effort, CLF shall maintain and provide a Speakers Bureau, disseminate research, documentation, and information, and develop and maintain a library of sources and materials on these subjects. Through Legal Assistance, CLF shall provide research, information, advice, and assistance to citizens, governmental, legislature, and law enforcement agencies involved in enactment, amendment, interpretation, enforcement and appeal of laws dealing with obscenity and

pornography and related issues. CLF shall seek to educate and assist in these efforts through conferences, seminars, workshops, courtroom participation, research and development of proposed laws and regulations, researching and preparing legal arguments for trials and appeals, filing briefs amicus curiae, and by providing attorneys, speakers, and other authorities to those public and official groups and agencies requesting assistance related to these issues and purposes.

It is the object of these programs and activities to encourage and improve the efforts to control and understand the problems and harms associated with the dissemination of that pornographic material which offends the moral standards of decency of the average person in the community. These efforts will also encourage and make more possible the dissemination of constructive and positive literature, movies, arts and theater which are possessed of serious value and which contribute toward a more decent and stable society and which foster and provide a healthy environment for the flourishing of a loving and loyal family structure and the presentation of public morality.
