

ARTICLES OF INCORPORATION Of VENEZIANO HOLDINGS, INC.

ARTICLE I NAME

SECHERARY OF STATE STATE OF IDAHO

The name of the Corporation is VENEZIANO HOLDINGS, INC.

ARTICLE II DURATION

The Corporation shall exist perpetually until such time as the real estate subject of this corporation shall have been disposed of.

ARTICLE III PURPOSE

The corporation is organized for the following purposes:

1. To purchase and develop for real estate in and through Idaho. Each preferred shareholder shall receive a pro-rated distribution from the net proceeds of sales assets real and otherwise upon in dissolution of the corporation.

2. To carry on any other business necessary to effectuate the above stated purpose.

ARTICLE 1V CAPITAL STOCK

A) Common voting shares: The Corporation is authorized to issue shares of no-par value common stock, which shall be designated "common voting shares".

B) Preferred Non-Voting Shares: The corporation is authorized to issue a 1,000,000 shares of \$1 par-preferred non-voting stock, which shall be designated "Preferred Non-Voting Shares".

C) Preferred Class Series A Non-Voting Shares: The corporation is authorized to issue 500,000 shares of \$1 par-preferred series non-voting stock, which shall be "Preferred Non-Voting Shares".

Pursuant to I.C. \sim 30-1-15, Preferred stock shall have preference in the assets of the corporation over any other class or classes of shares upon the voluntary or involuntary liquidation of the corporation.

Consistent with the purpose of the Corporation, each preferred shareholder shall receive a pro-rata distribution from the net proceeds of sale of the property subject of this corporation.



Preferred stock shall not be redeemable for cash or other consideration until such time as the property subject of this corporation has been sold.

ARTICLE VI INITIAL BOARD OF DIRECTORS

The Corporation shall have three directors initially. The number of directors may be either increased or diminished from time to time by the By-laws, but shall never be fewer than three (3). ARTICLE X AMENDMENT

The Corporation reserves the right to amend or repel any provisions contained in these Articles of Incorporation, or any amendment hereto, by a unanimous vote of the Board of Directors, and a two-thirds majority vote of the preferred shareholders.

ARTICLE XI AUTHORITY

The incorporator shall have authority to endorse, cash, deposit and negotiate all checks, cash and negotiable instruments on behalf of the corporation.
