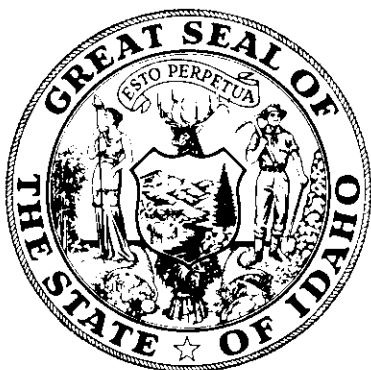

The undersigned, being of legal age, in order to form a corporation under and pursuant to the laws of the State of Idaho, do hereby set forth as follows:

FIRST: The name of the corporation is


