The undersigned, in order to form a Non-Profit Corporation under the provisions of Title 30, Chapter 3, Idaho Code, submits the following articles of incorporation to the Secretary of State.

#### **Article I Name**

The name of the corporation shall be Gospel Life Bible Church, Inc.

## **Article II Purpose**

This corporation is organized and operated exclusively for religious or charitable purposes within the meaning of Internal Revenue Code §501(c)(3). The specific purposes for which the corporation is organized are: (1) to make disciples of Jesus Christ through the power of the Holy Spirit; (2) to engage in such activities as are permitted to be carried on by a corporation exempt from federal income tax under §501(c)(3) of the Internal Revenue Code of 1986 (or the corresponding provision of any future United States Internal Revenue Law); (3) to accept donations and contributions for all the foregoing purposes; (4) to make distributions to corporations that qualify as exempt corporations under the §501(c)(3) of the Internal Revenue Code of 1986, or corresponding section of any future federal tax code; and (5) to do any and all other things necessary or incident to the above and foregoing purposes and powers and including all of the rights, powers and authority incident to general nonprofit corporations organized pursuant to the provisions of Title 30, Chapter 3, of the Idaho Code.

# Article III Registered Office and Agent

The street address of the registered office is 1123 12<sup>th</sup> Avenue Rd #286, Nampa, ID 83686 and the registered agent at such address is David Bronleewe.

#### **Article IV Directors**

This corporation shall have not less than three (3) nor more than nine (9) directors. The initial directors whose positions and duties are set forth in the bylaws will manage the affairs of this corporation. The names of the initial directors who are to serve are as follows:

## Article VII Membership

The corporation does not have voting members.

#### Article VIII Term and Dissolution

The term of this corporation shall be perpetual.

Upon the dissolution of the corporation, its remaining assets, if any, shall be distributed to Fellowship of Evangelical Churches, Inc for the religious charitable purpose of said corporation, so long as said organization is an existence and is an exempt organization within meaning of §501(c)(3) of the Internal Revenue Code, orcorresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not disposed of shall be disposed of by a court of competent jurisdiction in the county in whichthe principal office of the organization is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.

#### **Article IX Additional Provisions**

No part of the net earnings of the corporation shall ever inure to the benefit of, or be distributable to its members, directors, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article II. No substantial part of the activities of the corporation shall consist of carrying on propaganda, or otherwise attempting to influence legislation and the corporation shall not participate in or intervene in (including the publishing or distribution of statements) any political campaign on behalf of any candidate for public office.

Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on: (a) by a corporation exempt from Federal Income Tax under §501(C)(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue law or: (b) by a corporation, contributions to which are deductible under Section 170(C) of the Internal Revenue Code of 1986 or the corresponding provisions of any future United States Internal Revenue laws.
