ARTICLES OF INCORPORATION

OF STATE

KNOW ALL MEN BY THESE PRESENTS: That I, the undersigned, being a natural person of full age, a citizen of the United States and a resident of the State of Idaho, desire to form a corporation under and pursuant to the laws of the State of Idaho, and I do hereby certify as follows:

ARTICLE I

The name of this corporation shall be DAVID'S, INC.

ARTICLE II

The purpose for which this corporation is formed is for any lawful purpose.

ARTICLE III

The existence of this corporation shall be perpetual.

ARTICLE IV

The principal office or place of business of this corporation shall be at 1522 West Idaho Street, Boise, Ada County, Idaho; but the corporation may maintain an office in such towns, cities and places outside the State of Idaho as the Board of Directors may from time to time determine, or as may be designated by the By-Laws of said corporation. The corporate agent at said office is Dennis J. Sallaz.

ARTICLE V

The total amount of the authorized capital stock of this corporation is \$25, 000.00, consisting of 25,000 shares of common stock with a par value of \$1.00 per share.

ARTICLE VI

The members of the governing board of this corporation are styled "Directors", and the Board of Directors shall consist of at least one (1) and not more than seven (7), as may be provided by the By-Laws of the corporation.

ARTICLE VII

The capital stock of this corporation shall be non-assessable; and the private property of the shareholders, and each of them, of this corporation, shall not be subject to assessment or be liable for the debts, obligations or liabilities of this corporation.
