ARTICLES OF AMENDMENT

of the

ARTICLES OF INCORPORATION OF THE TRIBUNE PUBLISHING COMPANY.

KNOW ALL MEN BY THESE PRESENTS:

Publishing Company, a corporation duly organized under the laws of the State of Idaho, held at the office of the Company, in Lewiston, in the County of Nez Perce, State of Idaho, on the 28th day of June , 1930, after due and legal notice had been given to the stockholders thereof in conformity with its Articles of Incorporation, and the laws of the State of Idaho, at which all of the stock of said corporation was represented, the following amendment was adopted by the unanimous vote of all of said stock:

"BE IT RESOLVED That the capital stock of the Tribune Publishing Company be increased from \$30,000.00 to \$150.000.00 and the number of shares from 300 to \$1.500 , and that Article VI of the original "rticles of incorporation be amended to read as follows:
