ARTICLES OF INCORPORATION

KNOW ALL MEN BY THESE PRESENTS:

The undersigned incorporators, being natural persons of the age of eighteen years of more, and desiring to form a body corporate under the laws of the State of Idaho, hereby sign, verify and deliver in duplicate to the Idaho Secretary of State these ARTICLES OF INCORPORATION.

ARTICLE I

Name

The name of the Corporation shall be EYE OF THE STORM, INC. a nonprofit corporation hereinafter referred to as "THE CORPORATION."

ARTICLE II

Period of Duration

The corporate existence shall begin as of the date of the Certificate of Incorporation issued by the Secretary of State and shall be perpetual.

ARTICLE III

Purpose

A. The EYE OF THE STORM is incorporated for the express purpose of providing spiritual, emotional, mental and physical

B. Charitable, religious, and educational purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code of 1986, as amended from time to time, including, for such purposes, the making and distributions to organizations that qualify as exempt under such Section 501(c)(3).

C. to exercise all powers granted by the law necessary and proper to carry out the foregoing purposes, including, but not limited to, the power to accept donations of money, property, whether real or personal, or any other things of value. Nothing herein contained shall be deemed to authorize or permit the Corporation to carry on any business for profit, to exercise any power, or to do any act that a corporation formed under the Act, or any amendment thereto or substitute therefor, may not at that time lawfully carry on or do.

#### **ARTICLE IV**

##### **LIMITATIONS**

No part of the net earnings or assets of the Corporation shall inure to the benefit of, or be distributed to, its members, officers, or any other private persons except that the Corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article III hereof. No substantial part of the activities of the Corporation shall be for the carrying on of propaganda, or otherwise attempting to influence legislation, and the

Corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of any candidate for public office.

Notwithstanding any other provisions of these Articles, the Corporation shall not carry on any other activities not permitted to be carried on by a corporation exempt from federal income tax under Section 501(c)(3) of the Internal Revenue Code of 1986, as amended from time to time.

The Corporation shall not have any members.

**ARTICLE IX**

**DISTRIBUTION ON DISSOLUTION**

The EYE OF THE STORM shall have no assets for distribution upon dissolution. However, if there should be acquired assets, upon dissolution of the Corporation, the Board of Directors shall, after paying or making provision for the payment of all liabilities of the Corporation, distribute all the assets of the Corporation consistent with the purposes of the Corporation to such organization or organizations as shall at that time qualify as exempt organizations under Section 501(c)(3) of the Internal Revenue Code of 1986, as amended from time to time, in such manner as the Board of Directors shall determine. Any assets not so distributed shall be disbursed by the District Court of the County in which the office of the Corporation is then located, exclusively for the purposes or to such organizations, as such Court shall determine to be consistent with the purposes of the Corporation.

ARTICLE X

BYLAWS

Provisions for the regulation of the internal affairs of the Corporation shall be set forth in the Bylaws.
