## ARTICLES OF INCORPORATION.

MAGNEY, a citizen and resident of Deary, Idaho, hereby certify that we do voluntarily associate ourselves as a private business corporation, under and by virtue of the provisions of Chapter 1, Title IV. of Part Second (Civil Code) of the State of Idaho, 1909, and acts amendatory thereof; and set forth:

FIRST: That the name of the corporation is "BLUEBIRD MINING & REFINING COMPANY".

SECOND: That the purpose for which the corporation is formed is to conduct the business of:

- 1. Mining, smelting, refining, reducing, and dealing in and with all sorts of ores, metals and minerals, and the prospecting, locating, opening, operating and developing of mines, quarries, and mineral deposits of all descriptions.
