**ARTICLES OF INCORPORATION**  
**OF**  
**PARMA SUPPORT OUR STUDENTS EDUCATIONAL SCHOLARSHIP FOUNDATION INC.**

**I**

The name of this Corporation is Parma Support our Students Educational Scholarship Foundation Inc. This is an Idaho Non-Profit Public Benefit Corporation.

**II**

The period of existence and duration of the date of this Corporation shall be perpetual.

**III**

The address of the initial registered office of this Corporation is 24108 Ten Davis Rd, Parma, Idaho 83660; and the name of the initial Registered Agent at such address is Mary Helen Gotsch.

**IV**

This Corporation is organized under the Idaho Non-Profit Corporation Act, Idaho Code 30-301, and pursuant to Section 501(c)(3) of the Internal Revenue Code. This Corporation is a nonprofit public benefit corporation and is not organized for the private gain of any person. It is organized exclusively for charitable educational purposes (more specifically, scholarships for

students who have graduated from Parma High School) within the meaning of Section 501(c)(3) of the Internal Revenue Code including for such purposes the making of distributions to organizations that qualify as exempt organizations under Section 501(c)(3) of the Internal Code or corresponding section of any future federal tax code.

## VI

Upon the dissolution of the Corporation, assets shall be distributed for one or more exempt purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code, or corresponding section of any further federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by the Court of Common Pleas of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said court shall determine, which are organized and operated exclusively for such purposes.

## VII

This Corporation is not for profit and shall have no capital stock.

Pursuant to Idaho Code 30-314(e) and (g), the election of the subsequent Directors of this Corporation shall be by the Board of Directors which is located at the Parma School District Office at 805 East McConnell, Parma, Idaho.
