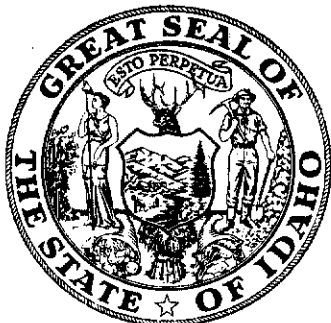

ARTICLES OF INCORPORATION

Known all men by this presents, we the undersigned citizens of the United States of lawful age, have today voluntarily associated ourselves for the purpose of forming a corporation, for the purposes expressed in Article III hereof, do hereby adopt the following Articles of Incorporation.

Article I

The name of the corporation shall be:
McDaniel Logging, Inc.

Article II

The period of its duration is perpetual.

Article III

The purpose for which this corporation is organized is for the business of logging and construction in the area in which it operates, and for transaction of any or all lawful business for which corporations may be incorporated.

Article IV

Provisions for the regulation of the internal affairs of the corporation shall be set forth in the by-laws of the corporation.

Article V

The shares of stock to be issued by the Corporation shall consist of one class only, and the aggregate number of shares which the Corporation shall be authorized to issue shall be 1,000 shares of stock, each having no par value.

Article VI

The registered agent of the corporation and the address of the initial registers office are as follows:

Article VII

The number of directors constituting the initial board of directors of the corporation is two (2), each of whom shall be members of this corporation, and qualifications, terms of office, manner of election, time and place of meetings, powers and duties of directors shall be prescribed in the by-laws of the corporation. The board of directors shall have the power to conduct all affairs of the corporation.

Article VIII

These articles of incorporation may be amended after approval by the board of directors, and by the majority of the voting members of the corporation, at a special meeting called for this purpose, or at a regular meeting, upon notice given ten (10) days prior to the date of such meeting, to all members of the Board of Directors.
