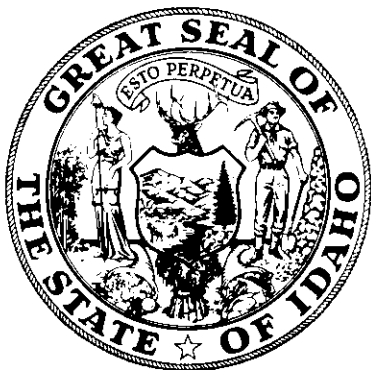

ARTICLES OF INCORPORATION

The undersigned, acting as incorporator of a corporation under the Idaho Business Corporation Act, adopts the following Articles of Incorporation for this corporation:

I.

The name of this corporation shall be IMPACT CRUSHING, INC..

II.

The period of existence and duration of the life of this corporation shall be perpetual.

III.

The address of the initial registered office of this corporation is STEPHEN J. JONES, and the name of the initial registered agent at such address is 1655 Verbena, Meridian, Idaho.

IV.

The nature of the business and the object and purpose of this corporation shall be as follows: provide rock crushing services and the transaction of any or all lawful business for which corporations may be incorporated under the Idaho Business Corporation Act.

V.

That the total authorized number of par value shares of this corporation shall be five thousand (5,000), each of a par value of one dollar (\$1.00), and of the aggregate par value of five thousand dollars (\$5,000.00), which said shares shall be common stock and shall not be subject to assessment.
