This is to certify: —

First - That we, the undersigned, have this day voluntarily associated ourselves, for the purpose of forming a corporation under the laws of the State of Idaho; —

Second - That the name of said corporation is Thainwood Brothers Company Limited;

Third - That the purposes for which said corporation is formed, are; to conduct a general merchandise and trading business at Boise City, Ada County, State of Idaho, or at any other place or places in said state or outside of said state, that may hereafter be selected by the board of directors of said corporation; to buy and sell, goods, wares and merchandise; to borrow and loan money; accept money on deposit, with or without interest, to discount on purchase notes, and other securities; to acquire, lease or dispose of real estate and personal property; and to make such other investments, and do such other acts and things as may be considered by the board of directors of said corporation, for the interest of the business of said corporation. —

Fourth. That the place where the principal business of said corporation is to be transacted shall be Boise City, Ada County, Idaho. —

Fifth. That the term for which said corporation is to exist is fifty years from and after the date of its incorporation. —

Sixth. That the number of the directors of said corporation shall be five; and that the names and residences of those who are appointed for the first year are: —
