# ARTICLES OF INCORPORATION 5 MIS! Eller Car Sange

KNOW ALL MEN BY THESE PRESENTS, that we, the undersigned being natural persons over the age of eighteen (18) years, do hereby form a general business corporation under the laws of the State of Idaho as contained in Title 30 of the Idaho Code entitled "General Business Corporations Act", and to that end do hereby set forth:

> The name of the corporation is: 1.

> > G & F, INC.

- The period of duration of this corporation shall 2. be perpetual.
- The purposes for which this corporation is organized are:
- Primarily to engage in the business of (a) manufacture and repair of utility and commercial trailers.
- To engage in such other businesses or activities which are lawful and authorized by Idaho Code Section 30-114.
- The county in the State of Idaho where the principal office for the transaction of business of the corporation is located is in the County of Twin Falls and the name of the registered agent is Dale Frank Bohman and the address of the registered office shall be Route 2, Buhl, Idaho 83316.
- The aggregate number of shares which the corporation shall have authority to issue is 25,000, having a

par value of \$1.00 per share. All of said stock shall be known as common stock and shall be nonassessable.
