5 KNOW ALL MEN BY THESE PRESENTS, that we, the
6 undersigned being natural persons over the age of eighteen (18)
7 years, do hereby form a general business corporation under the
8 laws of the State of Idaho as contained in Title 30 of the Idaho
9 Code entitled "General Business Corporations Act", and to that
10 end do hereby set forth:

11 1. The name of the corporation is:

12 G & F, INC.

13 2. The period of duration of this corporation shall
14 be perpetual.

15 3. The purposes for which this corporation is
16 organized are:

17 (a) Primarily to engage in the business of
18 manufacture and repair of utility and commercial trailers.

19 (b) To engage in such other businesses or
20 activities which are lawful and authorized by Idaho Code Section
21 30-114.

22 4. The county in the State of Idaho where the
23 principal office for the transaction of business of the
24 corporation is located is in the County of Twin Falls and the
25 name of the registered agent is Dale Frank Bohman and the
26 address of the registered office shall be Route 2, Buhl, Idaho
27 83316.

28 5. The aggregate number of shares which the
29 corporation shall have authority to issue is 25,000, having a

15 required by law.
