KNOW ALL MEN BY THESE PRESENTS:

The undersigned, acting as incorporators of a corporation under the Idaho Business Corporation Act, adopts the following Articles of Incorporation for such corporation:

FIRST:

The name of the corporation is MEDICAL COMPUTER SYSTEMS & RESEARCH, INC.

SECOND:

The period of its duration is: Perpetual.

THIRD:

The purpose or purposes for which said corporation is organized are: The transaction of any lawful business for which corporations may be incorporated under the Idaho Business Corporation Act.

FOURTH:

The aggregate number of shares which the corporation shall have authority to issue is: One Hundred Thousand (100,000) shares of voting common with a par value of Ten Dollars (\$10.00) per share.

FIFTH:

Provisions granting preemptive rights are: As contained in Idaho Code Section 30-1-26 and as that section reads this date.

SIXTH:

Provisions for the regulation of the internal affairs of the corporation are: The incorporators elect not to include such provisions in these Articles.

SEVENTH:

The address of the initial registered office of the corporation is 324 St. John's Way, Lewiston, Idaho, 83501, and the name of its initial registered agent at such address is Raymond S. Shields.

EIGHTH:

The number of directors constituting the initial board of directors of the corporation is two (2), and the names and addresses of the persons who are to serve as directors until the first annual meeting of shareholders or until their successors are elected and shall qualify are:
