

Pursuant to Section 30-18-501, et. seq. of the Idaho Entity Transactions Act, AB Bioenergy, LLC, an Idaho limited liability company (the "Company") hereby adopts the following Plan of Domestication:

1. The name of the domesticating entity is AB Bioenergy, LLC, an Idaho limited liability company.
2. The name of the domesticated entity is AB Bioenergy, LLC a Delaware limited liability company. The Certificate of Formation that will be filed with the Delaware Secretary of State is attached hereto as Exhibit A.
3. All property of the domesticating entity shall be vested in the domesticated entity without transfer, conveyance, assignment, reversion or impairment; all liabilities of the domesticating entity shall continue as liabilities of the domesticated entity. Except as otherwise provided by law all of the rights, privileges, immunities, powers and purposes of the domesticating entity remain in the domesticated entity.
4. Upon the filing of the Certificate of Formation with the Delaware Secretary of State, the Company shall be organized as a Delaware limited liability company and the terms of the Company's Operating Agreement dated effective March 1, 2010, shall continue to govern the Company.
5. This Plan of Domestication meets the requirements of Section 30-18-505(5) of the Idaho Entity Transactions Act regarding the filing of a Statement of Domestication and it therefore constitutes the same.
6. This Plan of Domestication for the Company was approved in accordance with the Idaho Entity Transactions Act, Sections 30-18-501, et. seq.
