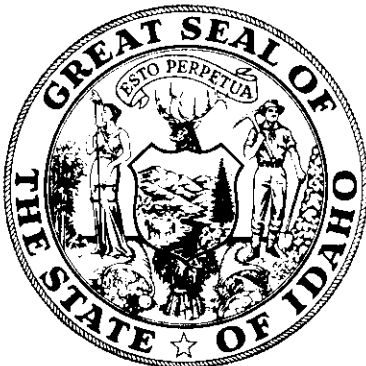

ARTICLES OF INCORPORATION
OF
BONNEVILLE FUNDING CORPORATION

The undersigned, acting as incorporator, in order to form a corporation for the purposes hereinafter stated, pursuant to the Idaho Business Corporation Act, do hereby adopt the following Articles of Incorporation for such corporation.

ARTICLE I

The name of the corporation shall be BONNEVILLE FUNDING CORPORATION.

ARTICLE II

The purposes for which said corporation is formed are:

A. To finance and arrange for financing for real estate projects and to buy assets and to lease those assets.

B. The transaction of any or all lawful business for which corporations may be incorporated under the Idaho Business Corporation Act.

ARTICLE III

The Corporation is to have perpetual existence.

ARTICLE IV

The address of the Corporation's initial registered office shall be 469 W. 16th St., *Idaho Falls* ⁶⁵⁰⁰⁰ *Idaho*, County of Bonneville, State of Idaho, and the name of its initial registered agent at such address is Frank J. Clark.

ARTICLE V

The capital stock of the Corporation shall be one hundred (100) shares of common stock, with \$1.00 par value. The capital stock of the Corporation shall not be assessable.

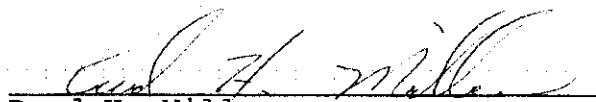

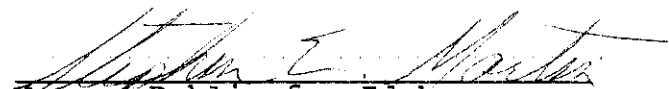
