2 under the Idaho Business Corporation Act.

3 7. Board of Directors. All corporate powers shall be exercised by or under the  
4 authority of, and the business and affairs of the corporation managed under the direction  
5 of, its board of directors, subject to any limitation set forth in a shareholder agreement  
6 authorized under section 30-1-732, Idaho Code. The number of directors constituting the  
7 initial board of directors shall be three (3), and the names and addresses of the persons to  
8 serve as directors until the first annual meeting of shareholders or until their successors are  
9 elected and qualified are:

17 to the extent that such amendment permits the corporation to provide broader  
18 indemnification rights than the Idaho Business Corporation Act permitted the corporation  
19 to provide prior to such amendment).


20 9. Limitation of Liability. No director shall be liable to the corporation or its  
21 stockholders for monetary damages for breach of fiduciary duty except liability for: (i) the  
22 amount of a financial benefit received by a director to which he is not entitled; (ii) an  
23 intentional infliction of harm on the corporation or the shareholders; (iii) a violation of §  
24 30-1-833, Idaho Code; or (iv) an intentional violation of criminal law.
