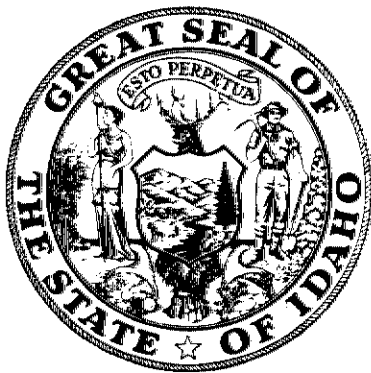

ARTICLES OF AMENDMENT RECEIVED
to the SEC. OF STATE
ARTICLES OF INCORPORATION 86 APR 21 PM 2 26

Pursuant to the provisions of Section 30-1-61 of the Idaho Business Corporation Act, Western States Equipment Company has adopted the following Articles of Amendment to its Articles of Incorporation:

I

The name of the corporation is Western States Equipment Company.

II

The following amendment to the Articles of Incorporation was adopted by the sole shareholder of the corporation on March 25, 1986, in the manner prescribed by the Idaho Business Corporation Act:

Article VI of the Articles of Incorporation of the corporation shall be amended to read as follows:

VI

The aggregate number of shares which this corporation shall have authority to issue shall be 10,000 shares of nonassessable, common stock having a par value of \$1,000 each.

Each outstanding share entitled to vote shall be entitled to one (1) vote on each matter submitted to a vote at a meeting of the shareholders. Votes may not be cumulated.

III

The number of shares of the corporation outstanding at the time of such adoption was ten, and the number of shares entitled to vote thereon was ten.

IV

The number of shares voted for such amendment was ten, and the number of shares voted against such amendment was 0.

V

Such amendment does not effect a change in the amount of stated capital of the corporation.
