ARTICLES OF INCORPORATION SECRETARY OF STATE OF TOAHOTE

THE UNDERSIGNED, acting as incorporator of a corporation under the Idaho Professional Service Corporation Act, adopts the following Articles of Incorporation for such corporation:

FIRST

The name of the corporation is RONALD L. WILLIAMS, P.C.

SECOND

The period of its duration is perpetual.

THIRD

The corporation is organized for the sole and specific purpose of rendering professional legal services within the state of Idaho and for no other purpose, as provided by Idaho Code Section 30-1307.

FOURTH

The aggregate number of shares which the corporation shall have authority to issue is 1,000 with a par value of \$1.00 per share.

FIFTH

Only individuals who are licensed to practice law in the state of Idaho may be shareholders of the corporation. Shareholders shall have a preemptive right to acquire unissued or treasury shares or securities convertible into such shares or carrying a right to subscribe to or acquire shares, except as provided in the Idaho Business Corporation Act.

SIXTH

SEVENTH

The number of directors constituting the initial Board of Directors is one (1) who is Ronald L. Williams and Ronald L. Williams shall serve until the first annual meeting of the shareholders and until his successor is elected and qualified.

EIGHTH

HTMIN

The Board of Directors is expressly authorized to alter, amend or repeal the Bylaws of the corporation and to adopt new Bylaws, subject to repeal or change by a majority vote of the shareholders.

TENTH

A director of this corporation shall not be personally liable to this corporation or its shareholders for monetary damages for breach of fiduciary duty as a director, except for liability (a) for any breach of the director's duty of loyalty of this corporation or its shareholders, (b) for acts or omissions not in good faith or which involve intentional misconduct or a knowing violation of law, (c) under Section 30-1-48, Idaho Code, or (d) for any transaction from which the director derived an improper personal benefit. If the Idaho Business Corporation Act is amended to authorize corporate action further eliminating or limiting the personal liability of directors, then the liability of a director of this corporation shall be eliminated or limited to the fullest extent permitted by the Idaho Business Corporation Act, so as amended. Any repeal or modification of this Article Eleventh by the shareholders of the corporation shall not adversely affect any right or protection of a director of the corporation existing at the time of such repeal or modification.
