ARTICLES OF THIRD AMENDMENT TO THE SECRETARY OF STATE ARTICLES OF INCORPORATION OF STATE OF IDAHO GUARDIAN NORTHWEST INSURANCE COMPANY, INC.

Pursuant to the provisions of Section 30-1-59 of the Idaho Business Corporation Act, the undersigned Corporation adopts the following Articles of Amendment to its Articles of Incorporation:

### ARTICLE I

Prior to the effective date of these Articles of Amendment, the name of the Corporation was Guardian Northwest Insurance Company, Inc.

#### ARTICLE II AMENDMENT ADOPTED
