KNOW ALL MEN BY THESE PRESENTS, that we, the undersigned being natural persons over the age of eighteen (18) years, do hereby form a general business corporation under the laws of the State of Idaho as contained in Title 30 of the Idaho Code entitled "General Business Corporations Act", and to that end do hereby set forth:

- The name of the corporation is: A & D DEVELOPMENT, INC.
- The period of duration of this corporation shall be perpetual.
- 3. The purposes for which this corporation is organized are:
 - The transaction of any or all lawful (a) business for which corporations may be incorporated under the Idaho Business Corporations Act.
