ARTICLES OF INCORPORATION

OF

The undersigned, acting as incorporator of a corporation under the Idaho Business Corporation Act, adopt the following Articles of Incorporation for such corporation:

1. **NAME**: The name of the corporation is Heritage Safe Company, Inc.
2. **DURATION**: The period of its duration is perpetual.
3. **PROFIT**: This is a profit corporation.
4. **PURPOSES**: The purpose or purposes for which the corporation is organized is to own and operate a business involving manufacturing and sales of safes, and for the transaction of any or all lawful business for which corporations may be incorporated under the Idaho Business Corporation Act.
5. **SHARES AUTHORIZED**: The aggregate number of shares which the corporation shall have authority to issue is one thousand (1,000) shares of no par value common stock.
6. **PRE-EMPTIVE RIGHTS**: Shareholders shall have pre-emptive rights to acquire unissued or treasury stock or securities convertible into or carrying a right to subscribe to or acquire shares.
7. **BUSINESS AFFAIRS**: Provisions for the regulation of the internal affairs of the corporation are such as may be provided by the corporation's By-Laws, including restrictions on the transfer of shares.
