subscribe to any shares of any class of this corporation, now or hereafter to be authorized, or any notes, debentures, bonds, or other securities convertible into or carrying options or warrants to purchase shares of any class, now or hereafter to be authorized, whether or not the issuance of any such shares, or such notes, debentures, bonds or other securities, would adversely affect the dividend or voting rights of such stockholder, other than such rights, if any, as the Board of Directors, in its discretion from time-to-time may grant, and at such price as the Board of Directors in its discretion may fix; and the Board of Directors may issue shares of any class of this corporation, or any notes, debentures, bonds, or other securities convertible into or carrying options or warrants to purchase shares of any class, without offering any such shares of any class, either in whole or in part, to the existing stockholders of any class.

WE, THE UNDERSIGNED, being each of the original incorporators hereinbefore named for the purpose of amending the Articles of Incorporation pursuant to the General Corporation Law of the State of Nevada, do make and file this Certificate of Amendment of Articles of Incorporation, hereby declaring and certifying that the facts herein stated are true, and accordingly adhere to set our hands this 22nd day of September , 1980.
