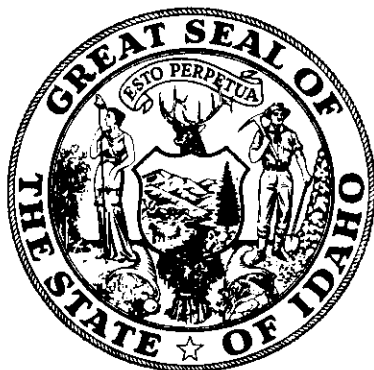

ARTICLES OF INCORPORATION

OF

DEAL CORPORATION

ARTICLE I

NAME

The name of this corporation is DEAL CORPORATION.

ARTICLE II

DURATION

This corporation shall have perpetual existence.

ARTICLE III

PURPOSES

The purpose for which this corporation is organized is the transaction of any or all lawful business for which a corporation may be incorporated under the Idaho Business Corporation Act.

ARTICLE IV

CAPITALIZATION

This corporation is authorized to issue only one class of shares, which shall be designated "common" shares. The total authorized number of such shares, which may be issued is FIVE THOUSAND (5,000). All of such shares shall have a ONE DOLLAR (\$1.00) par value.


