Dear Mr. Pankey:

Your letter dated March 7, 2012 requesting approval of the assumed business name "Kooskia Food Bank" for use in the state of Idaho has been received by the Idaho Department of Finance (Department) and has been reviewed by Department staff. We understand from your letter that Clearwater Food Bank conducts business as "Kooskia Food Bank" in the Kooskia, Idaho community and collects cash and non-cash donations to meet and help the needy within that community. Further, we understand that the company will not operate in Idaho as a depository institution or conduct the business of banking.

Section 26-1202 of the Idaho Bank Act prohibits any person, other than a national bank, not authorized to operate as a bank under the Act, to advertise or use as part of its company name the word "bank" or "banker" or any other word of similar import. The Idaho Bank Act does not authorize the Director of the Idaho Department of Finance to waive the requirements of the law. Rather, the Department is offering "no objection" to the company's use in Idaho of either "Clearwater Food Bank" or the assumed business name "Kooskia Food Bank." Based upon the information provided in your letter, we do not believe the name proposed by that company for use in Idaho is misleading to the public. While the Department does not intend to pursue an action under this statute, it is possible that another agency may do so. However, we believe the likelihood is slight.
