Corporate Shares**

Effective immediately Hubert B. Olson retires from corporation. Shares of the Corporation are to be distributed as follows;

1. Randall Olson 10% or 20 Shares
2. Chong H. Haynes 89.5% or 179 Shares
3. Ernest Jones 0.5% or 1 Share

Officers**

The following officers are hereby appointed.

1. Randall Olson (Chief Executive Officer/President)
2. Chong H. Haynes (Chief Financial Officer/Treasurer)
3. Ernest Jones (Secretary/Registered Agent)

**Article Nine
Management and Authority**

The officers shall have Management responsibilities and authority as hereby set forth herein;

1. Randall Olson (President) Day to day operation of businesses including, but not limited to;
 - a. Entrance into contracts, and agreements with;
 1. Vendors and suppliers.
 2. Customers.
 - b. Supervision of employees, and subcontractors with the autonomous authority to hire and fire.
 - c. Operate as "managing officer".
2. Chong H. Haynes (Chief Financial Officer/ Treasurer) Operate as Chief Financial Officer, solely responsible for;
 - a. The approval of all financial transaction, and distributions.
 - b. Enter into "Credit Accounts" for the "Corporation"
 - c. Supervision of the Registered Agent in his authority to liaise with financial institutions.
3. Ernest Jones (Secretary/Registered Agent)
 - a. Act as Registered Agent for "The Corporation".
 - b. As directed by "The Chief Financial Officer" liaise with financial institutions, and conduct business including opening and closing of accounts.
 - c. As directed by Chief Executive Officer as liaison, and conduct business as necessary.
