## ARTICLES OF INCORPORATION

## LEWISTON FUN CENTER, INC.

The undersigned, acting as incorporators of a corporation under the Idaho Business Corporations Act, adopt the following Articles of Incorporation for such corporation:

FIRST: The name of the corporation is LEWISTON FUN CENTER, INC. SECOND: The period of its duration is perpetual.

THIRD: The purposes for which the corporation is organized are:

To conduct, for a profit, and engage in the business of furnishing entertainment and diversion to the public either indoors or outdoors, including but not limited to operation of a Go-cart track, amusement rides, pin-ball machines and other mechanical games, snack bar, and other food and drink dispensing both through machines and direct sales, and to grant concessions to individuals, companies and corporations to conduct at such places of amusement particular businesses for the amusement and entertainment of the public, and to do any and all things necessary to and pertaining to said business, anywhere in the United States, and particularly in Idaho.

To have one or more offices and places of business in and out of the State of Idaho, and to acquire, receive, hold, purchase, lease, mortgage, sell, invest in, and convey real and personal property both connected with said business or otherwise, and both in and out of the State of Idaho.

To do all and everything necessary, suitable and proper for the accomplishment of any of the purposes or the attainment of any of the objects or the furtherance of any of the powers herein set forth, either alone or in association with other corporations, firms or individuals, and to do every act or thing incidental or appurtenant to ARTICLES OF INCORPORATION

or growing out of or connect with the aforesaid objects or purposes, or any part or parts thereof, provided the same be not inconsistent with the laws under which this corporation is organized, and to use and apply surplus earnings or cumulative profits to the purchase or acquisition of its own capital stock, from time to time and to such extent and in such manner and upon such terms as its board of directors shall determine.

To enter into contracts or obligations of any kind or type essential, necessary or proper to the transaction and conduct of its ordinary affairs for the purposes of the corporation; to contract and hire labor necessary or convenient to the conducting and operation of said business, and to do any and all things regularly, necessarily, properly or incidentally done in the conduct of said business, and to have all the power to generally engage in, do and perform any enterprise, act or vocation that a natural person might or could do or perform, connected with the general overall objects and purposes for which this corporation is formed.

FOURTH: The aggregate number of shares which the corporation shall have authority to issue is TWO THOUSAND (2,000), all of which shall be common stock having a par value of ONE HUNDRED DOLLARS (\$100.00) each.

FIFTH: The address of the initial registered office of the corporation is 602 21st Street, Lewiston, Idaho 83501.

SIXTH: The name of the initial registered agent of said corporation at its registered office is ROBERT G. COREY.

SEVENTH: The number of Directors constituting the initial board of directors is two (2) and the names and addresses of the persons to serve as directors until the first annual meeting of the shareholders or until their successors are elected and shall qualify ARTICLES OF INCORPORATION 2.
