The undersigned, the President and Secretary of Preco, Inc. ("Preco"), do hereby certify the following Articles of Merger.

- Preco owns 157,520 shares of the common stock of Santa Clara Plastics & Mfg. Co., a California corporation ("SCP"), which shares constitute one hundred percent (100%) of the issued and outstanding common stock of SCP. SCP has no issued and outstanding shares of preferred stock.
- SCP shall be merged into Preco, with Preco being the surviving corporation, effective on December 31, 1984.
- In exchange for its shares of common stock of SCP, Preco shall receive all of the assets of SCP, subject to the liabilities of SCP that exist on the effective date of the merger.
- Following the effective date of the merger, the operations previously conducted by SCP shall be operated as a division of Preco utilizing the names "Santa Clara Plastics" and "SCP."
- 5. A copy of the Plan of Merger was mailed to the sole shareholder of SCP on October 18, 1984.
