## ARTICLES OF INCORPORATION

The undersigned, acting to incorporate a corporation under the Idaho Business Corporation Act, adopt the following Articles of Incorporation for such corporation:

- 1. NAME: The name of the corporation is GraceWay, Inc.
- 2. DURATION: The period of its duration is perpetual.
- 3. PURPOSES: This corporation may transact any and all lawful business for which corporations may be incorporated under the Idaho Business Corporation Act, but shall initially provide an acute care, non-medical treatment facility for children and adolescents with behavior or emotional problems.
- 4. SHARES AUTHORIZED: The aggregate number of shares which the corporation shall have authority to issue is ten thousand (10,000) shares at One Dollar (\$1.00) par value common stock.
- 5. PREEMPTIVE RIGHTS: Shareholders shall have preemptive rights to acquire unissued or treasury stock or securities convrtible into or carrying a right to subscribe to or acquire shares.
- 6. BUSINESS AFFAIRS: Provisions for the regulation of the internal affairs of the corporation are such as may be provided in detail by the corporation's By-Laws, including restrictions on transfer of shares.
- 7. REGISTERED AGENT AND OFFICE: The initial registered agent is:
