That the undersigned, being a bona fide United States citizen, over the age of twenty-one years, does, under and in pursuant to the general corporation laws of the State of Idaho, hereby organize, constitute and associates ourselves, and such other persons as may hereafter become associated with us, into a body politic and corporate, and to that end execute the following ARTICLES OF INCORPORATION and do hereby set forth and declare as follows:

I

That the name of the corporation is, and shall be A.E.T, INC.

This corporation shall have perpetual existence.

III
