The directors shall meet at a date deemed timely by the directors and adopt a set of bylaws to govern the future operations of the corporation. Adoption and enactment of the bylaws shall take place when a majority of the charter membership are in favor of said adoption.

ARTICLE IX. Dissolution. Should a decision to dissolve the corporation be voted upon by the membership and put into effect, the assets of the corporation shall be liquidated and disbursed firstly to any outstanding liabilities, and thereafter to another like non-profit corporation in the theatre community.

ARTICLE X. Tax Reporting. For federal, state, and local tax reporting purposes it is intended that this corporation shall be formed under the non-profit 501-C3 rules and regulations.
