ARTICLES OF INCORPORATION
OF
INTERACTIVE SOFTWARE DESIGNS, INC.

The undersigned, acting as incorporators of a corporation under the Idaho Business Corporation Act, Title 30, Chapter 1, Idaho Code, adopt the following Articles of Incorporation for such corporation:

FIRST: The name of the corporation is INTERACTIVE SOFTWARE DESIGNS, INC..

SECOND: The period of the corporation's duration is perpetual.

THIRD: The purpose for which the corporation is organized is the transaction of any or all lawful business for which corporations may be incorporated under the Idaho Business Corporation Act, including, but not limited to, the design, development, sale, and distribution of computer software and related products.

FOURTH: The aggregate number of shares which the corporation shall have authority to issue is 3,000, all of one class, at a par value of \$0.50.

FIFTH: Provisions denying preemptive rights are: None.

SIXTH: Provisions for the regulations of the internal affairs of the corporation are: None.

SEVENTH: The address of the initial registered office of the corporation is 953 North Cleveland, Moscow, Idaho 83843, and the name of its initial registered agent at such address is Sunil Sharma.
