The undersigned, acting as an incorporator of saccompositions under the Idaho Business Corporation Act, hereby adopts the following Articles of Incorporation for such corporation:

FIRST: The name of the corporation is Panhandle Off-Road Vehicle Association, Inc., a non-profit corporation, pursuant to Idaho Code Section 30-3-1, et seq.

SECOND: The purpose or purposes for which the corporation is organized are:

The transaction of any or all lawful business for which corporation may be incorporated under the Idaho Business Corporation Act, including, but not limited to, conduct as a recreational off-road vehicle association.

THIRD: The corporation shall have members who shall be subject to qualification and voting as set forth in the bylaws of the corporation. The management of the affairs of the corporation shall be vested in the Board of Directors.

FOURTH: The address of the initial registered office of the corporation is Dale E. Newberry, 715 Camas Street, Moscow, Idaho 83843, and the name of its initial registered agent at such address is Dale E. Newberry.

FIFTH: The corporation's duration shall be perpetual. Upon dissolution, the assets of the corporation shall be distributed in accordance with I.C. §§ 30-3-109, 30-3-114, and 30-3-115.
