## ARTICLES OF INCORPORATION

0F

## FRIENDS OF CENTENNIAL PARK, INC.

KNOW ALL MEN BY THESE PRESENTS, That we, the undersigned all of whom are bona-fide residents of the State of Idaho and citizens of the United States, have this day voluntarily associated ourselves together for the purpose of forming a non-profit corporation under the laws of the State of Idaho.

We do hereby certify, in writing, the following:

Ι.

This corporation is a non-profit corporation formed pursuant to the "Idaho Non-Profit Corporation Act". No part of the net earnings shall inure to the benefit of any private shareholder.

II.

The name of the said corporation shall be known as: FRIENDS OF CENTENNIAL PARK, INC. The principal place of business shall be in the County of Custer, State of Idaho, and the post office address shall be P. O. Box 303, Challis, Idaho 83226. The name of the registered agent and the agent's address are: President, Loretta Veach, #3, Mountain View Drive, Challis, Idaho 83226.

III.

The corporation shall be nonstock, and no dividends or pecuniary benefits or profits shall be declared to the members thereof.

The period of existence and the duration of the life of this Corporation shall be perpetual. Upon the winding up and dissolution of this Corporation, after paying or adequately providing for the debts and obligations of the organization, the remaining assets shall become the property of the Challis Park and Recreation Board.

٧.

The qualifications upon which members shall be accepted and expelled or reinstated shall be provided for in the By-Laws of said Corporation.

VI.

The relative rights of members are equal and are included in the By-Laws.

VII.

All other provisions relative to membership and election or appointment of officers or directors and all matters relative to the holding of meetings shall be provided for in the By-Laws.

VIII.

The officers of this Corporation shall consist of a President, Vice-President, Secretary and Treasurer, and six additional Directors, to be appointed or elected as provided for in the By-Laws, unless otherwise provided for in the By-Laws or amended By-Laws. Any member may hold more than one elective or appointive office or position.
